By signing this agreement, buyer and seller both agree to the following:

- This kitten is guaranteed to be healthy before leaving Kings Kitties Ragdolls. Upon Receiving the kitten the buyer has 3 days (72 hours) to have a complete physical examination done by a licensed veterinarian of their choosing. Kitten must be kept secluded from all other pets until after this examination. **Note this health guarantee is completely void if buyer fails to have a licensed veterinarian examine the kitten within 3 days (72 hours) of purchase.** All veterinarian care and fees are the responsibility of the buyer. Kitten will need additional vaccines.
- Your kitten has a TWO year guarentee from the DATE OF BIRTH above against lethal genetic or congenital defects. Including Hypertrophic Cardiomyopathy (HCM). Buyer must immediately notify Kings Kitties Ragdolls and provide a written statement from a licensed veterrarian stating the life-threatening illness or congenital defect. If a lethel genetic or congenital defect presents itself within the first two years that results in death, Kings Kitties Ragdolls shall replace kitten (minus shipping charges, if applicable) upon being provided a necropsyreport (at buyers expense)from a licensed veterinarian stating the unquestionable genetic or congenital defect that resulted in death. No replacement will be given without a necropsy. Buyer agree to give authorization for Kings Kitties Ragdolls to make verbal contact with the examing licensed veterrarian before replacing the kitten. Kings Kitties Ragdolls will then replace the kitten with an equal quality kitten that is chosen by Kings Kitties Ragdolls. Kitten will be replaced within one year of notification date. **NO EXCEPTIONS! NO VETERINARY EXPENSES OR MONETARY REFUNDS FOR A CAT/KITTEN PURCHASED FROM KINGS KITTIES RAGDOLLS WILL BE GIVEN FOR ANY REASON WHATSOEVER.**
- This kitten is guarenteed negative for FeLV, and FIV and free of fleas at the time of purchase and for 72 hours thereafter. Viruses, diarrhea, colds and upper respiratory infections are not covered under this guarentee as they may be contracted after leaving and are not the results of genetics or breeding. FIP is covered ONLY until kittens 6 month birth date and a replacement will be offered after a necropsy is performed at the buyers expense, confirming FIP. Kings Kitties Ragdolls has no control over what cat/kitten is exposed to once kitten leaves our home. Kings Kitties Ragdolls does not make any guarentees about personality, size or coat color. Kings Kitties Ragdolls is not responsible for any allergies to cat/kitten and any allergies are not covered under this guarentee.
- Kitten is not to be resold under any circumstances. If the kitten is found to have been sold or given away, the health guarentee is void and not transferable. No refunds will be given for a cat/kitten purchased from Kings Kitties Ragdolls.

- This kitten must be kept in a clean, INDOOR environment. All veterinary expenses and yearly vaccines are the responsibility of the buyer. A copy of the kittens health records have been provided with the kitten. Buyer agrees that an FVRCP booster AND a Rabies vaccine will NOT be given at the same time as a potentially life threatening reaction may occur. Kings Kitties Ragdolls does not warranty cat/kitten from any adverse reactions against future vaccinations.
- Kitten is not to be declawed as this is an inhumane procedure that is the amputation of the tip of the bone in the kittens toes and can cause side effects due to not healing properly. Keep nails trimmed and provide scratching posts.

Spay and Neuter Policy

- If kitten is purchased as a “Pet Only” or “Show Quality” then the kitten must be spayed or neutered within 3 months from the date of pickup or by 6 months of age. The buyer must provide proof to Kings Kitties Ragdolls with a copy of veterenarian invoice stating that the kitten has been spayed or neutered. This invoice must include the licensed veterenarians name who preformed the surger and office phone number. Must also include the kittens birth date, breed and coat color.
 - If kitten is purchased as a “Pet Only” or “Show Quality” the buyer agrees that the kitten will never be bred under any circumstances. Should the buyer not meet the requirements of the spay and neuter policy, an additional payment of \$3000 will be due immediately to Kings Kitties Ragdolls and buyer will then recieve breeding rights. This should happen if buyer fails to notifiy Kings Kitties Ragdolls with valid confirmation of the spay or neuter by a licensed veterenarian within the kitten turning 6 months of age. NO EXCEPTIONS.

- Note: Any disputes or claims shall be brought to the State of Ohio, and reinstating in venue will not be allowed in any other state other than Ohio. Any disputes or claims will be held only at the Mahoning County Courthouse. Buyer will be responsible for all costs and legal fees for buyer, as well as Kings Kitties Ragdolls (This includes for breach of contract).
